## Mission and Principles

This initiative is an extension of our existing distributive campus model with a mission to *Enable Access to Quality Pharmacy Education* for learners within our region and beyond. The Pioneer Pathway has been carefully designed to synergize with our traditional pathways, preserving the unique elements of training that distinguish our school from other programs. Envisioned with the same commitment to academic rigor and outcomes, the pathway is anchored in *three foundational principles*:

- Fusion of expert faculty instruction with cutting-edge digital learning technology, design, and support.
- Continuous and valuable student engagement and support complemented by hands-on immersions.
- Structured flexibility, empowering students to tailor their learning pace within predefined time constraints.

### Program overview

The Pioneer Pathway allows students the flexibility to complete the initial two years of their training in a remote, structured learning environment using a combination of online asynchronous and synchronous coursework and inperson immersions. The third year is transitional. In the fall semester, students experience a blend of similarly structured remote coursework and didactic electives and complete a six-week structured community practice IPPE at a site local to the student. In the spring, students integrate into the traditional pathway, joining one of our four campuses to complete their three remaining six-week IPPEs and concurrent spring coursework. Students also complete their first five APPE blocks and Grand Rounds course at this campus. Students preference campus assignment at enrollment based on existing procedures. Students may also opt to complete their entire P3 and/or P4 year on the traditional pathway. This strategic approach ensures a minimum of twelve months of face-to-face and experiential learning on an assigned campus, providing the opportunity to develop a robust foundation of clinical skills, attitudes, behaviors, and professional identity through highly structured IPPE and core APPE rotations - elements our program is widely recognized for.

## Introduction and Program History

The TTUHSC School of Pharmacy is dedicated to *enhancing the lives of patients through innovation and excellence in education, practice, and research*. At the core of our mission are values that champion innovation in a dynamic healthcare landscape and prioritize a curriculum that centers on the learner. The Piorneer Pathway is the perfect combination of both core values because it incorporates novel technologies to reshape our traditional curriculum into a self-directed, faculty-mentored pathway. This strategic approach extends our educational reach to students far beyond our physical campuses and enables TTUHSC School of Pharmacy to effectively address the demand for skilled pharmacists. By adopting the alternative pathway, we ensure that high-quality pharmacy education is accessible to learners, irrespective of their geographic location.

The planned launch date for this new pathway is August 1, 2024, with recruitment beginning in January 2024. The recruitment target for the first year is 24 students. This is the typical section size for most hands-on and small group learning activities within our existing program. This size allows the school to feasibly demonstrate preparedness for delivery of the pathway and to ensure optimal support of learners by existing faculty and team members.

In pursuit of our program, we are committed to ensuring that our program not only maintains but enhances the quality, rigor, and engagement that are integral to our school's educational mission. Program design and implementation is guided by the following tenets:

- Prioritizing program quality and academic rigor
- Embracing engagement and professional identity formation
- Agile innovation that id deliverable but pragmatic
- Creating a framework fo collaboration and truse
- Cultivating synergy between new and traditional offerings
- Fostering support for both learner and educator, and
- Ensuring strategic support and resource allocation.

The curricular planner and full course descriptions of all traditional PharmD courses are found in the main SOP catalogue. A detailed listing of Pioneer Pathway courses, by semester is found at the end of this document. In most cases, Pioneer Pathway students enroll in the same courses/course numbers as traditional pathway students, simply enrolling in a course section specific to to the Pioneer Pathway. However, in some cases, Pioneer Pathway courses are given unique course numbers to facilitate construction of courses which, though the same in content to traditional pathway courses, have schedules unique to Pathway learners. These are denoted in the course planner with the § symbol. Descriptions of these courses are included with those of the traditional courses, and are differentiated for the Pioneer Pathway with italicized text.

## Immersion experiences

#### **Minimum Immersion Time by Semester:**

Based on current calculations, students would be required to travel to the Amarillo campus for 2 x 40 hour weeks each semester. Based on immersion hours, it may be possible to reduce this to 3 trips per year, but the committee has not yet identified a strategy that aligns with HSC census requirements for fall and spring semesters. Number of hours allocated to immersions each semester are based primarily on input from laboratory course team leads; experiential course activities are based on existing requirements. The 1

SCH Correlations courses were scheduled to reflect 8 of 14 sessions (57%) delivered face-to-face. The following outlines proposed immersion requirements per semester. Immersion weeks will be identified in advance to facilitate travel. Immersions will be scheduled and posted in the Academic Calendar. Additional time within immersion weeks may be used to support cocurricular activities, professional identity formation, orientation/development, and health service activities. Fall P3 immersion is shorter, may occur on another campus, and could be scheduled in tandem with IPE or other activities.

#### **Student success coaches**

In this role, and are responsible for evaluating individual needs, motivating students to work towards their goals, and monitoring their progress. Their duties include:

- Provide proactive and individualized success coaching to an assigned caseload of students.
- Empower students to effectively communicate with faculty and student services and become better connected to resources and support services such as financial aid, career services, and disability services.
- Engage in educational planning activities to help guide them to achieve their educational goals.
- Provide one-on-one coaching related to personal and/or professional development.
- Staying connected with students at all times.
- Identify at-risk students within an assigned caseload of students using reports and analyzing data and
  providing proactive outreach to at-risk students, connecting them with appropriate interventions and
  student supports.
